6 W's of Performance Measures

- What are Performance Measures?
 - Measures that will accurately reflect the progress and accomplishments of the Pregnancy Assistance Fund Initiative grants
- Why collect them?
 - Accountability and reporting to stakeholders
 - Program management
- Who sees them?
 - OAH all
 - Congress some
- How are they reported to Congress?
 - At an aggregated level no grantees will be identified
- When are they collected?
 - Reporting period covers the grant year August 1st July 31st
 - October 30th is the reporting deadline, the same date as for the annual progress report
- Where are they collected?
 - PAF Website

Measures for All Grantees

- Participant Characteristics will enable us to see
 who is being reached by the program
 - Number by category (e.g., expectant female teens)
 - For expectant and parenting participants:
 - Number by age
 - Number by ethnicity
 - Number by race
 - Number by marital status
 - Number by living arrangements
 - Number by financial and social support (gender separate)
 - Number by type of services received

Measures for All Grantees (cont.)

- Non-Participant Extended Family Characteristics
 - Number by category (e.g., parent)
 - Number by type of services referred
- Extended Family Members
 - Number by type of services referred

Measures for All Grantees (cont.)

- Training
 - New Staff Receipt of Initial Training
 - Existing Staff Receipt of Supplemental or Follow-up Training
- Partners
 - # of Formal or Informal Implementation Partners
 - # of Partners who Remain Engaged throughout Program Year

Grantees Working with Institutions of Higher Education (IHEs)

- Number of expectant and parenting IHE students by type of IHE
- Number of expectant and parenting IHE students graduated by type of IHE
- Number of expectant and parenting IHE students enroll in next semester or quarter of classes by type of IHE
- Number of parenting IHE students 19 years and younger who report a new pregnancy during program year

Grantees Working with High Schools or Community Service Centers

- Number of expectant and parenting students by high school enrollment status and grade level
- Number of expectant and parenting students who dropped out
- Number of expectant and parenting students who pass
 GED
- Number of expectant and parenting students who either pass GED or graduate who are accepted into an IHE
- Number of parenting IHE students 19 years and younger who report a new pregnancy during program year

Grantee Programs who Work with Women who Experienced Stalking, Sexual Assault, or IPV

- Number of individuals from different agencies serving individuals who experienced stalking, sexual assault, or IPV who received training on violence against pregnant and parenting teens and women
- Number of expectant and parenting female participants who experienced stalking, sexual assault, or IPV who received services by type

Grantee Programs who are Increasing Public Awareness and Education

 Number of public awareness or education strategies implemented by the program by type

Optional Measures
