

RESOURCE: SURVEY ITEMS

All Tier 2b and 2c evaluations are required to collect at least one behavioral outcome measure that is eligible for review under the HHS TPP Evidence Review. While 2015 Tier 2b and 2c evaluations will not be required to report individual data to OAH as performance measures, the nine measures in the "Behavioral Questions about Sexual Intercourse" section below should be collected as part of your evaluation studies and included in your final evaluation report. The required questions cover sexual initiation, pregnancy, recent sex, recent sex without a condom and recent unprotected sex (i.e. risky sexual behavior). Six supplementary sets of questions that may be useful are provided in an effort to promote standardization of measures: (1) Intentions about vaginal sex, (2) Additional behavioral question on recent vaginal sex, (3) Additional behavioral questions on oral sex, (4) Additional behavioral questions on anal sex, (5) Pre-sexual behavioral questions (intended for young populations), and (6) Sexual orientation and gender orientation.

Evaluators should use these questions as worded for consistency across evaluations if they align with the programs' goals. Evaluators are welcome to utilize additional relevant survey items as they wish in their studies, i.e. use of emergency contraception could be included as a separate question, as the items below are narrow in scope and not intended to be exhaustive. HHS encourages grantees and evaluators to coordinate with each other to share existing measures/constructs or to develop new ones for their projects. To create and engage in a learning community with your TPP colleagues around measures, we invite you to utilize the collaboration space in the TPP MAX.gov system.

<u>Behavioral Questions about Sexual Intercourse – italicized text should be removed on the survey</u>

The next questions are about vaginal sex. By vaginal sex, we mean a penis in a vagina. Please do not report on episodes of oral or anal sex in this section. In a later section, there are questions about oral and anal sex.

Tip: Use of condoms and birth control are separated here but depending on your research questions/intended final outcomes you may want to consider combining questions 4 and 5 into a single question if that best fits the goals of your evaluation.

Tip: If count measures are key outcomes of interest, you could consider following this with a subsequent question that provides ranges for youth who respond "don't know" to the initial question. Counts could then be imputed within the banded range or you could use a categorical variable for your outcome. This may reduce non-response for a key outcome measure.

Note: Combining questions 4 and 5 is allowable so that the list includes both condoms and birth control. If condoms and birth control are separated as shown, the ability to determine "risk of pregnancy" in the past 3 months is lost because the reported non-use of a condom (from question 4) and non-use of other methods (from question 5) may not be reported for the same sex act. To resolve this issue, use question 5b. (Also see question 9).
